Terms and Conditions

1. Methods of Payment

- (a) Payment shall be in US dollars.
- (b) Payment shall be Credit Card, Money order, Bank cashier's check or Bank wire transfer.
- (c) Payment terms shall be: **Prepaid**
- (d) Cheques: Only with prior approval and to be made payable to: **MILSAR Group Inc.**

2. Methods of Shipment

- (a) Freight collect; all order are F.O.B. (Freight On Board) Seattle Wa.
- (b) All orders shall be shipped from the US
- (c) Ship by FedEx or United States Postal Service (Postal International Air Express service).
- (d) Merchandise Insurance shall be applied by the request from the buyer.

3. Warranties

- (a) Limited Thirty (30) day warranty. All warranties begin from the date of invoice.
- (b) ADONIS Skate Wheels limited warranty covers only manufacturer's defects.
- (c) ADONIS Skate Wheels is not liable for any failure of other parts on roller skates.
- (d) No ADONIS Skate Wheels employees, agents, or dealers are authorized to make any modification, extension, or addition to this limited warranty.

4. Return Policy

(a) All return requests must be made within fifteen (15) calendar days after the invoice date. If the request of return is granted, an RMA (Return Merchandise Authorization) will be issued. We reserve the option to accept or reject non-defective returns.

(b) Returns will not be accepted without prior authorization and must be accompanied by a copy of the invoice. Buyer must return merchandise to ADONIS Skate Wheels within ten (10) calendar days after the RMA is issued. If the merchandise is not returned within the authorized time period, the RMA will be canceled. Products must be packed securely and be returned to ADONIS Skate Wheels undamaged, with Buyer being solely responsible for paying all return freight costs.

(c) Merchandise is subject to inspection before replacements will be issued. We reserve the right to return to the Buyer any non-defective merchandise or any merchandise that does not match the invoice.

(d) We reserve the right to issue refunds in exchange for returned merchandise, or to replace merchandise with repaired, used, or reconditioned parts.

5. Returned Checks: Checks returned for any reason are subject to US \$40.00 service charge.

6. Refused Shipment: Buyer may be subject to no less than a ten percent (10%) restocking fee, shipping charges, and any losses incurred to ADONIS Skate Wheels, for the package refused without prior authorization.

7. Shipping Errors: Shipping errors should be reported within 48 hours after receipt of the merchandise(s).

8. Damaged Shipment: Claims of damaged shipments must be made by the buyer with the carrier. All the shipping cartons and packing materials should be kept for carrier inspection.

9. Cancellation of Back Orders: To avoid any restocking fees and freight charges, the cancellation of back orders should be notified to ADONIS Skate Wheels before the scheduled date.

10. Price: ADONIS Skate Wheels list prices are subject to change without notice.

11. Product Specifications: All specifications (materials, designs, etc.) are subject to change without notice.
